The college is recognised by the Indian Nursing Council (I.N.C.) as well as the Kerala Nursing and Midwifery Council and is affiliated to the Kerala University of Health Sciences (KUHS).

ADMISSION TO B.Sc. NURSING COURSE on N.R.I. CATEGORY SEATS

Academic Year 2024–25 Prospectus & Instructions to the Applicants

- 1. Applications for admission to first year B.Sc. Nursing (Academic year 2024 25) in the 05 Numbers of NRI category seats at this college is being invited on the basis of this prospectus.
- 2. **Academic Eligibility:** To be eligible to apply for the B.Sc. Nursing course, the applicant must have completed and passed the 10 + 2 examination with 50 % marks under the Kerala State Higher Secondary Board (Kerala HSC) OR Central Board of Secondary Education (CBSE) OR Indian School Certificate Examination (ICSE) after a period of 12 years study, the last two years of study comprising of Physics, Chemistry and Biology with English at a level not less than the core course for English as prescribed by the National Council for Educational Research and Training (NCERT).

Note:

- All applicants must have taken courses in Biology, Physics and Chemistry in addition
 to English in the High School Years (during their 10th, 11th and 12th). They should
 have secured at least 80% marks in Biology, Physics and Chemistry at the Plus
 Two level.
- Wherever alphabetical grades like A, B+, C+, etc. are used by the school, appropriate equivalence in terms of percentage like 90%, 75% and 60% should be made available.
- Only students from high schools accredited by the respective State or the country and as such approved by the Association of Indian Universities and Kerala University of Health Sciences will be eligible for admission and Equivalency Certificate to this effect shall be produced.

- 3. **Age Requirements:** Applicants should complete <u>17 years of age on 31st December 2024</u> (the date of birth being shown on the Matriculation or equivalent certificate).
- 4. Eligibility for admission to N.R.I. Category Seats: According to the GO(MS) No.243/2014/H&FWD dated 06.08.2014, "An Applicant who depends upon his/her Father / Mother / Brothers and Sisters (inclusive of first cousins) / Husband / Wife / Brothers and Sisters (inclusive of first cousins) of Father or Mother / Half Brother / Half Sister / Adopted Father or Adopted Mother who is working abroad" will only be eligible to apply in the NRI category seats.
- 5. The following documents shall be submitted:
 - A candidate, who apply for the NRI seat should submit the Passport copy and Visa/Green Card/<u>OCI Documents</u> of their respective sponsors attested by the embassy. The Job of the sponsor should be mentioned in any of the above documents.
 - ii. The **Visa of the sponsor should be valid** till the closing date of admission in respect of the Medical and Allied Courses **attested by the embassy**.
 - iii. In case, the employment of the sponsor is not mentioned in the above documents, the candidate has to produce **the employment certificate of the sponsor attested by the Embassy/ Consulate authorities**.
 - iv. The certificates clearly establishing the relationship of the sponsor with the candidate shall be obtained from the revenue authorities, as per the G.O (Ms) No. 243/14/H&FWD dated 06.08.2014.
 - v. However, the relationship between the candidate and his/her father/mother, which are recorded in the educational certificates, maintained in the usual course of transactions by the competent authorities, shall be accepted.
 - vi. The Candidate shall produce the sworn **affidavit from the Sponsor** in a stamp paper worth Rs. 200/-. The same shall also be notarized by the Notary Public, disclosing that the student is dependent of the sponsor and the all expenses i.e. tuition fee and special fee, of the candidate for the entire course period will be borne by the Sponsor.
 - vii. All the certificates/documents required for establishing NRI Status shall be produced at the time of submission of application itself. The certificate produced later shall not be entertained under any circumstances.
 - viii. The NRI relative who is sponsoring the candidate should be an Indian Citizen/Overseas citizen of India/Person of Indian Origin and relevant document to prove the same.

Note: Apart from the schedule of fees given above, the students will be required to pay the proportionate examination fee, etc. payable to the University from time to time. Hostel & Mess fee will be charged separately.

HOW TO APPLY: Online through College Website

- **a.** Application Form will be available from 12th June 2024 onwards on the website of the college www.littlelourdescollegeofnursing.com
- b. Details of the Demand Draft, that is to be filled in as part of the online Application form. (Application Fee is Rs.2000/- (Rupees Two thousand only) as D.D. in favour of Little Lourdes College of Nursing, Kidangoor, Kottayam). The Demand draft has to be kept ready before filling the online form. The online application will prompt you to fill in (1) DD No. (2) Bank Name, (3) Branch, (4) Amount and (5) Date.
- c. Before applying online candidates should have:- A valid email ID (we recommend Gmail.ID)
- d. Scanned copy of recent (taken latest in 2024) passport size color photograph. Photograph should be taken in a white/light color background. The image should be in **JPEG** format maximum size for photograph **50kb** and image dimension is **120 x150 pixels**.
- e. Scanned copy of Student and guardian Signature
- f. Fill up the Self declaration form Annexure 1
- g. Scanned copy of the Certificate. The image should be in JPEG/PDF format. Maximum size for JPEG/ PDF files 500KB
 - SSLC
 - Plus Two
 - TC and course & conduct Certificate
 - Aadhar
 - NRI related all documents (**Ref No.5**)
- h. The duly filled application form should be submitted together with self-attested copies of

necessary certificates as mentioned above and an application fee of Rs.2,000/- (Rupees Two thousand only) as DD in favour of Little Lourdes College of Nursing payable at Kidangoor, Kottayam

The hard copy of filled in online applications, with photo of the candidate should reach Little Lourdes College of Nursing, Kidangoor P.O., Kottayam-686572, Kerala *not* later than 3:00 pm, on 15th July 2024. The applicants, at their own interest, are advised to send the applications by Registered Post. *The college cannot be held responsible for non-receipt or late receipt of applications, under any circumstances*. The application form should be completed carefully; furnishing the entire information called for. Late and incomplete applications and applications not in the prescribed format will be summarily rejected.

- 7. While reporting **for admission** the entire relevant certificates/documents **original as listed below should be submitted to the institution**.
 - a) School Leaving Certificate (S.S.L.C.) of student establishing that the student has completed 17 years of age as on 31-12-2024.
 - b) HSCE or equivalent examination mark-sheet / pass certificate.
 - c) Anti-Ragging Certificate from the institution last attended (preferably issued within six months).
 - d) Conduct Certificate from the head of the Institution last studied in proof of the clause (**prohibition of Ragging, point 11**) of this prospectus.
 - e) Transfer Certificate.
 - f) Migration Certificate.
 - g) Copy of Aadhar ID proof.
 - h) Copy of the format of online application form.
 - i) Every candidate before admission to the course shall submit to the Principal of the Institution a Certificate of Medical Fitness from an authorized Medical Officer with MBBS or higher qualification certifying that the candidate is fit to undergo the course.
 - j) Passport size photograph 8 Nos. and Stamp size 2 Nos.
 - k) Additionally, four sets of photocopies of all the above certificate/documents attested by Gazetted officers have to be submitted at the time of admission.
 - 1) Print out of online application form.
 - m) NRI related all documents (Refe. no. 5 above).
 - n) A statement to show that the high school in which the student has studied has been accredited by the State/Country/University (if applicable).
 - o) Equivalence Certificate from Association of Indian Universities (if applicable).
 - p) Eligibility certificate from Kerala University of Health Sciences (if applicable).
- 8. As per the regulations of the University and the Regulatory Council, admissions will have to be

closed by 30^{st} September 2024. After closure of admissions, the seat, if vacated, cannot be

filled up. Such seats will go vacant for the entire duration of the course. Therefore, those who

leave the course after the closure of admissions will have to pay liquidated damages equivalent

to the tuition fees for the remaining period of the course. Any complaints in this regard shall be

subject to the legal and factual scrutiny and the decision of the ASC/FRC.

9. All students who get selected should get themselves vaccinated against Hepatitis before

admission. A vaccination certificate shall be produced at the time of admission or before

commencement of the course.

10. Every student is required to adhere strictly to the Code of Conduct of the college.

11. Ragging is strictly prohibited. If it is found during the admission or any time there after that

the applicant has indulged in ragging in the past, admission may be refused or the student shall

be expelled from the institution. Whoever commits, participate in, abets or propagate ragging

within or outside the institution shall be suspended from the institution with immediate effect

and the Principal shall report the matter to the civil/police authorities.

12. Without prejudice to the directions of the Nursing Councils/Government/University, the

decision of Rev. Sr. Immaculate SVM, President, Little Lourdes College of Nursing shall be

final on all matters with regard to admission.
